### Please read carefully:

- Only full members of WQ TMA can nominate another full member to stand for selection to the Board of WQ TMA.
- All nominations must be made in writing and sent by email to arrive no later than **5pm Thursday 22<sup>nd</sup> November 2018.**
- Receipt will be acknowledged by email within two working days.
- Section 1: Must be filled out and signed by two nominators (both of whom must be fully paid up members of WQ TMA). The contact information needs to be completed in full.
- Section 2: Must be filled out by the nominee who needs to provide their contact information. The nominee is the person that is seeking election to the Board of WQ TMA as a representative of their organisation. The nominee's organisation must have been already accepted as a full member of WQ TMA, having completed and submitted a membership application form.
- If representing an organisation then any seat on WQ TMA Board belongs to that organisation and not to the individual.
- If there are insufficient nominations to fill all vacant seats those who have applied will be automatically elected to the Board. The remaining vacant seats will become casual vacancies. (Please see WQ TMA Rules for details).
- If the number of nominations is equal to the number of vacant seats the persons nominated will be deemed to be elected
- If the number of nominations exceeds the vacancies then a poll will be conducted at the AGM to be held on Thursday 29<sup>th</sup> November 2018.
- The election process is covered in Section 15 of the Rules of WQ TMA.
